

**SUMMARY ANNUAL REPORT FOR

This is a summary of the annual report of the KEENAN HOPKINS SCHMIDT AND STOWELL CONTRACTORS, INC. EMPLOYEE BENEFIT PLAN, a health, life insurance, dental, vision, temporary disability's accidental death and long-term disability plan (Employer Identification Number 59-2471479, Plan Number 501), for the plan year 07/01/2022 through 06/30/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

KEENAN HOPKINS SCHMIDT AND STOWELL CONTRACTORS, INC. has committed itself to pay all Health, Dental and Vision claims incurred under the terms of the plan.

**Insurance Information**

The plan has insurance contracts with CIGNA Health and Life Insurance Company, United Healthcare Insurance Company, Colonial Life & Accident Insurance Company to pay all Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Temporary Disability, Accident and Critical Care claims incurred under the terms of the plan. The total premiums paid for the plan year ending 06/30/2023 were \$579,278.
